

Privacy Policy (ArcelorMittal Ohio)

Effective date: June 11, 2026

ArcelorMittal Ohio (“we,” “us,” “our”) respects your privacy. This Privacy Policy explains how we collect, use, share, and protect personal information when you visit <https://www.arcelormittal-oh.com/> (the “Site”), and the choices you have.

1) What this policy covers

This policy applies to personal information collected through the Site, including information you provide through forms, and information collected automatically (such as device and usage data). It does not cover information collected offline or through other ArcelorMittal websites or services unless stated.

2) Personal information we collect

We may collect the following categories of information:

A. Information you provide

- **Contact details** (such as name, email address, phone number, company name)
- **Message content** you submit through contact forms or inquiries
- **Job-related information** if you apply or inquire about employment (such as resume/CV details, work history, education, and other information you choose to provide)

B. Information collected automatically

When you use the Site, we may automatically collect:

- **Device information** (IP address, browser type, operating system, device identifiers)
- **Usage information** (pages viewed, links clicked, time spent, referring/exit pages)
- **Approximate location** (derived from IP address)
- **Cookie and similar technology data** (see “Cookies” below)

3) How we use personal information

We use personal information to:

- **Operate and improve the Site** (performance, troubleshooting, analytics)
- **Respond to inquiries** and provide requested information
- **Communicate with you** about your request or relationship with us
- **Support recruiting and hiring** activities if you submit employment-related information
- **Maintain security** and prevent fraud, abuse, or illegal activity
- **Comply with legal obligations** and enforce our rights

4) Legal bases (where applicable)

Depending on your location, we process personal information based on:

- **Your consent** (for example, certain cookies or marketing communications where required)
- **Our legitimate interests** (such as operating, securing, and improving the Site)
- **Contractual necessity** (to respond to requests or provide services you ask for)
- **Legal obligations** (to comply with laws and regulations)

5) Cookies and similar technologies

We use cookies and similar technologies (such as pixels and tags) to help the Site function, understand usage, and improve performance.

Types of cookies may include:

- **Strictly necessary cookies** (required for basic site functionality)
- **Analytics/performance cookies** (help us understand how visitors use the Site)
- **Functional cookies** (remember preferences)

You can control cookies through your browser settings. If you disable cookies, some parts of the Site may not work properly.

Note: If the Site uses a cookie banner or preference center, you can manage cookie choices there as well.

6) How we share personal information

We may share personal information with:

- **Service providers** that help us operate the Site (hosting, analytics, security, form processing, IT support). They are permitted to use personal information only to perform services for us.
- **Affiliates and related entities** where appropriate for internal administration, security, or responding to your request.
- **Legal and safety disclosures** if required by law, court order, or to protect rights, safety, and security.
- **Business transfers** if we are involved in a merger, acquisition, reorganization, or sale of assets (information may be transferred as part of that transaction).

We do **not** sell personal information for money. If your jurisdiction defines “sale” or “sharing” broadly (e.g., certain advertising-related disclosures), you may have additional rights described below.

7) International data transfers

Your information may be processed in countries other than where you live, which may have different data protection laws. Where required, we use appropriate safeguards for cross-border transfers.

8) Data retention

We keep personal information only as long as necessary for the purposes described in this policy, including to meet legal, accounting, or reporting requirements, resolve disputes, and enforce agreements.

9) Security

We use reasonable administrative, technical, and physical safeguards designed to protect personal information. No website or system can be guaranteed 100% secure, so please use caution when submitting information online.

10) Your privacy rights and choices

Depending on your location, you may have rights such as:

- **Access** to personal information we hold about you
- **Correction** of inaccurate information
- **Deletion** of certain information
- **Objection or restriction** to certain processing
- **Data portability**
- **Withdraw consent** where processing is based on consent

To request to exercise your rights, contact us using the information in the “Contact us” section below. We may need to verify your identity before fulfilling certain requests.

11) Children’s privacy

The Site is not intended for children under 13 (or under the age defined by local law), and we do not knowingly collect personal information from children. If you believe a child has provided personal information, please contact us so we can take appropriate action.

The Site may contain links to third-party websites or services. We are not responsible for the privacy practices of those third parties. Please review their privacy policies before providing information.
